Mr. Parker provided a brief conference overview and commended everyone on working together to complete the mission of corrections. A special recognition to Bryan Collier and his work with the Professional Development Committee and Tom Stickrath for his leadership in the Commission on Accreditation for Corrections.

ACA Executive Director James A. Gondles, Jr. welcomed committee members and ACA staff along with the many professionals in the audience. Mr. Gondles encouraged everyone to attend the healthcare luncheon on Friday, August 5, 2022 from 12:00-1:30 pm with limited seating at the La Nouvelle, Ballroom As well as the health care reception held on the same date at the Marriott New Orleans, Carondalet from 5:30-6:30 pm. In addition, the General Session Friday August 5, 2022 at 1:30 pm in the Ernest N. Morial Convention Center with President-Elect Denise Robinson and renown actress, and humanitarian Ashley Judd discussing mental illness and suicide. On Sunday, August 7, 2022, the sold out E. R. Cass Banquet will begin at 6:00 pm at the Sheraton New Orleans, Napoleon Ballroom honoring Damon Hininger and Anadora (Andie) Moss.

Commission Chair, Mr. Thomas Stickrath acknowledged ACA for keeping the audits and panel hearings moving forward during the global wide pandemic. Virtual panel hearings were conducted throughout as needed or requested. Mr. Stickrath mentioned that 190 facilities were up for accreditation, 17 of which are initial accreditations, and 15 international facilities from Colombia, Costa Rica and Mexico.

Auditor training will be held Friday, August 5, 2022 beginning at 8:00 am. Anticipated publications include a 2022 Supplement, 5th Edition ACI, ALDF and JCF Manuals by January 2023.

Discussion on Monitoring Visits during Accreditation Award period.
Gary Mohr, Immediate Past President
James A. Gondles, Jr., Executive Director

Immediate Past President Gary Mohr addressed the committee regarding the subject of Monitoring Visits during the three-year Accreditation Award period. This initiative was originally discussed during Past President Livers term and during Immediate Past President Mohr's term; however, was suspended in early 2020 with the onset of the pandemic. The corrections industry has long been the subject of criticism and at times appears to be an easy target. Periodic visits to those accredited facilities will strengthen the validity of continued compliance with expected practices while providing an intensified view of the process to the corrections industry, professionals and public in general.

There will be a recommendation made to the American Correctional Association Board of Governors to consider and implement a course of action to formalize monitoring visits during the Accreditation Award period. Specifically Past President Mohr will recommend a proposal to the Board of Governors to task the Commission on Accreditation for Corrections to develop an implementation plan to conduct the site visits and report to ACA in January 2023.

Comments:

One portion of this standard states "a writing surface and proximate area to sit." Despite direction being given at auditor training that they are not to audit the comment, and Panel decisions approving the appeal of this finding, auditors still focus solely on the comment: "Comment: The words "writing surface" refer to a fixed or free-standing surface under which a person can sit." Making this standard non-compliant, despite portable writing surfaces being available, and acknowledging that adding fixed writing surfaces would decrease the unencumbered space that the cells already are lacking, thereby further affecting the quality of life.

Respectfully request removing the comment completely, or providing direction that portable writing surfaces are sufficient IF the cell does not meet the required unencumbered space as required in 5-ACI-2C-01, or 5-ACI-4B-06.

Where applicable, the agency must submit a completed Significant Incident Summary and Outcome Measures Worksheet with the required Annual Report.

Comments: The current standard requires annual reports to be submitted on the anniversary of the accreditation date. Even absent COVID, this leaves a 6 month gap for facilities between audit date, and when they are granted accreditation. Since COVID, accreditation panels have been held outside of conference dates, further blurring the timelines. It would be more beneficial to the auditors onsite if the reports were from audit anniversary to audit date, as that is the timeline they are onsite to review.

Respectfully request revision of the standard to require reports to be submitted on the anniversary of the audit date.

Comments: Prison systems should ensure they meet the specific laws governing this specific population.

COMMENTS:

(1) The term vocational needs to be replaced with Career and Technical Education. (2) The term juveniles likely needs to be changed. Individuals under the age of 18 incarcerated in an adult correctional facility often are adjudicated as an adult and are defined as an adult by state law. The adjudication may constitute "expressly waived by law" as written in the comment. This proposed standard needs further explanation for clarity. (3) There are other High School Equivalency tests besides GED. It is recommended that the "for instance" comment not be included.
